
PROJECT BACKGROUND




USER CASE MODEL

Actors and Use cases









- AWAITING APPROVAL CSR ADMIN (WHEN THE APPROVER APPROVES THE PROJECT AND COST > 20L)
- REJECTED (WHEN THE APPROVER REJECTS THE PROJECT)
- ASSIGNED (WHEN THE CONTRIBUTOR ASSIGNS THE PROJECT TO THEMSELVES)
- ASSIGNED NEED IMPLEMENTORS (WHEN THE CONTRIBUTOR ASSIGNS THE PROJECT TO THEMSELVES AND THERE IS A NEED FOR IMPLEMENTORS)
- COMPLETED (WHEN THE PROJECT IS COMPLETED)

BACKGROUND

THIS SECTION SUMMARIZES THE RATIONALE FOR PROPOSING THE SOLUTION. THE OPPORTUNITY IS TO BUILD A CSR PORTAL TO MANAGE THE CSR PROJECTS EFFICIENTLY AND EFFECTIVELY. THE PORTAL WILL BRING TRANSPARENCY IN CSR ACTIVITIES. AS IT WILL BE EASIER THE STAKEHOLDERS INVOLVED TO TRACK ΔLL **OF IMPLEMENTATION** THE PROJECTS. THE PORTAL WILL FACILITATE CREATION OF SOCIAL DEVELOPMENT PROJECTS BY PROPOSERS.
