

Digital Geo-Spatial Survey of Plantations

The Plantation Directorate was constituted under the Department of Industries and Commerce during the year 2022–23 with the objective of promoting the plantation sector and ensuring its long-term sustainability and profitability through appropriate government interventions.

At present, the Directorate primarily depends on limited data sourced from the Labour Department, which does not sufficiently capture the comprehensive information required for effective planning, monitoring, and policy formulation for the plantation sector.

To address this data gap and to develop a comprehensive, accurate, and up-to-date plantation database, the Directorate proposes to undertake a State-wide digital survey covering all major plantations. A detailed Data Collection Proforma has already been developed to guide the survey process.

Further, it has been decided to conduct a detailed geo-spatial survey, including geo-mapping of plantation areas and labour line houses, to enable spatial analysis and evidence-based decision-making.

In this context, the Directorate proposes to engage a competent Startup with demonstrated expertise in geo-spatial technologies, digital data collection, and platform/application development to design and implement the survey in a technologically robust, scalable, and efficient manner.
